---

Open Educational Resources (OER) can be any type of material or resource used for teaching available in the public domain that is free to use and/or alter.

OER include many types of resources in different media and formats: course lessons/syllabi, course materials, student guides, teaching notes, textbooks, videos, and more.

# The 5Rs of Openness

---

## Retain

The right to make, own, and control copies of the content

## Revise

The right to adapt, adjust, modify, or alter the content itself



## Reuse

The right to use the content in a variety of ways

## Remix

The right to combine original or revised content with other open content

## Redistribute

The right to share copies of original content, revisions, or remixes

# Three principles of Social Justice Applied to Open Education

---

## Redistributive Justice

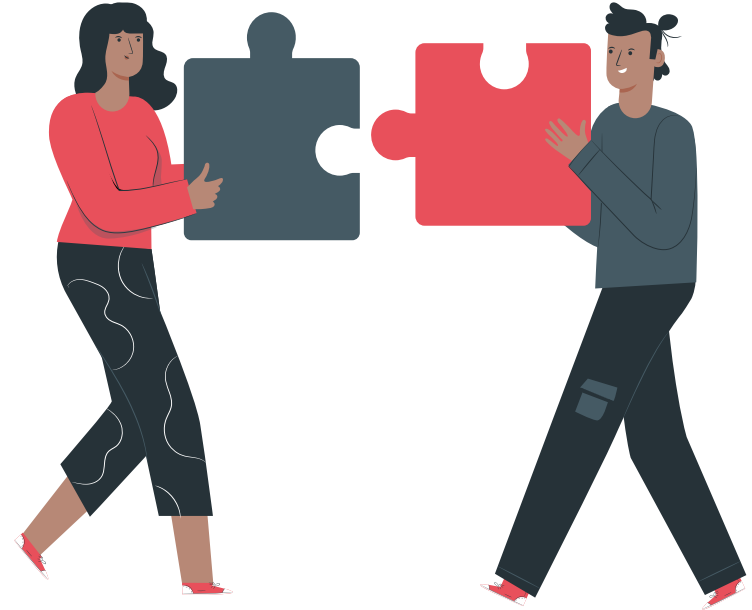
- Saving Students Money
- Student Success

## Recognitive Justice

- Editable for visibility and recognition
- Inclusive language & images

## Representational Justice

- Open Pedagogy
- Opportunities for marginalized groups to tell their own stories

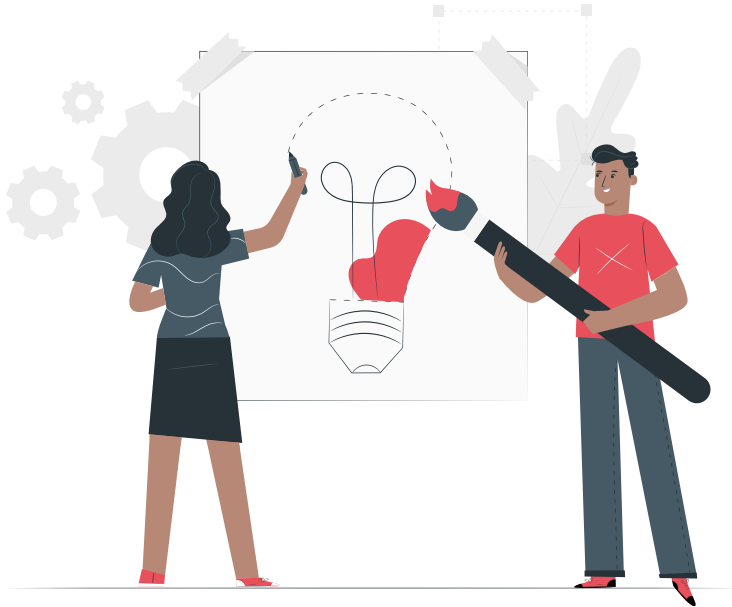

# Constructivism

---



Constructivism is 'an approach to learning that holds that people actively construct or make their own knowledge and that reality is determined by the experiences of the learner' (Elliott et al., 2000, p. 256).

- Knowledge is socially constructed
- Learning is an active process
- Knowledge is personal
- Students as collaborators of knowledge
- Learners can contribute knowledge into something tangible and public



# Disposable Vs. Renewable

---

## Disposable Assignments

"These are assignments that students complain about doing and faculty complain about grading. They're assignments that add no value to the world – after a student spends three hours creating it, a teacher spends 30 minutes grading it, and then the student throws it away. Not only do these assignments add no value to the world, they actually suck value out of the world."

-David Wiley, What is Open Pedagogy?

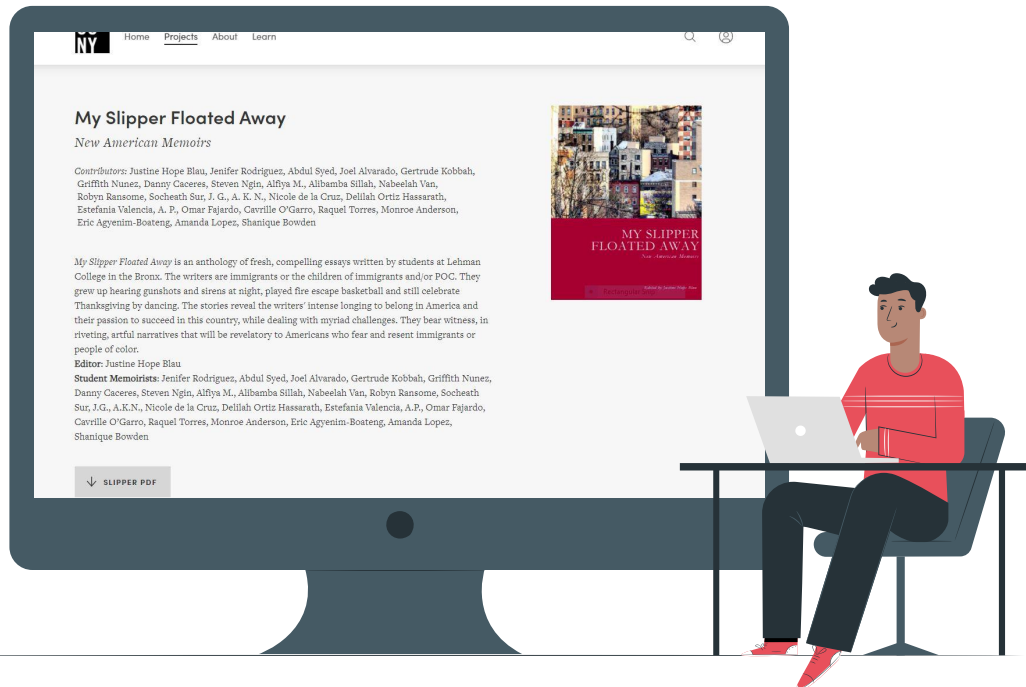
## Renewable Assignments

"Renewable assignments provide students with opportunities to engage in meaningful work, add value to the world, and provide a foundation for future students to learn from and build upon. Renewable assignments are possible because of the permission to engage in the 5R activities granted by open educational resources (OER)."

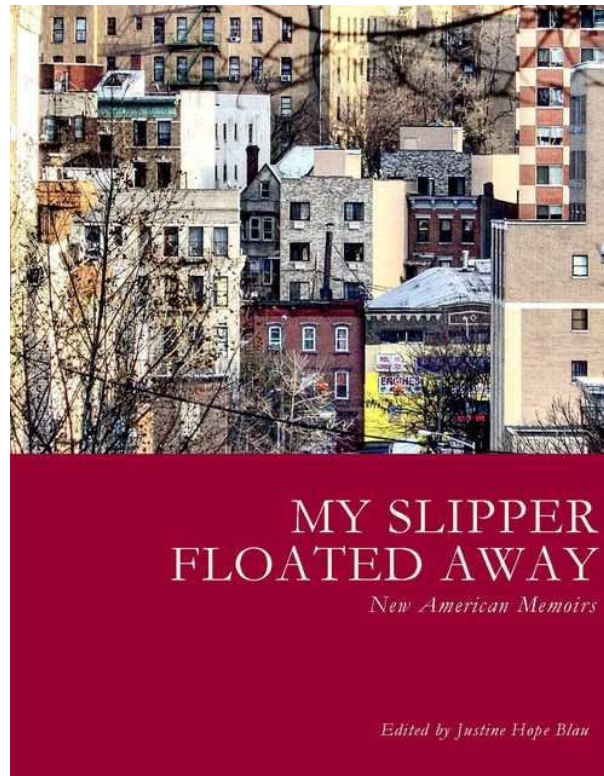


# My Slipper Floated Away: New American Memoirs
